## Auditor's report

This auditor's report is issued for the purposes of an opinion about the emissions presented in the "emissions report" to the "EU Registry" which is only authorised to use this report within the scope of trading emissions/emission reductions in a future NO<sub>x</sub> and SO<sub>2</sub> emission trading system including shipping.

### Introduction

In accordance with instructions described in document "Demo Project Phase 1 Draft Report (version 2003-08-25)", we have reviewed the enclosed emissions report (Cooper and Flodström, "Continual NO<sub>x</sub> emission monitoring on board Manon and Stena Jutlandica", IVL report U826, 2003 (Phase 2a)) from the ship "Manon" of Wallenius Lines including the underlying documents based on completeness, accuracy and materiality. The emissions report is the responsibility of IVL1. Our responsibility is to express an opinion on the emissions report.

### Scope


We conducted our review in accordance with generally accepted auditing standards in Sweden and the instructions outlined in document "Demo Project Report Draft version 030825". Those standards and instructions require that we plan and perform the review to obtain reasonable assurance about whether the report and the reported emissions are free of material misstatement. A review includes examining, on a test basis, evidence supporting the figures presented in the emissions report. We believe that our review provides a reasonable basis for our opinion.


### Opinion

In our opinion, the emission report have been prepared in accordance with the instructions outlined in document "Demo Project Report Draft version 030825" and give a true and fair view of the emissions and emission reductions created by "Manon". Based on our work, the information provided to us by IVL and Wallenius Lines, and the materiality level presumed in the DEMO project we report the following results:

- We have not identified any material misstatement or misleading assumptions in the reported emissions and emissions reductions presented in the emissions report referred to above
- As a result from the presumed materiality level, the reported uncertainty and reviewed uncertainty calculations a deduction from the reported reductions has been done.
- We can verify **emission reductions of 620 kg NO<sub>x</sub>** (achieved by Manon the 18<sup>th</sup>-19<sup>th</sup> July, 2003) and report these verified emission reductions to a potential EU Registry.
