The **main challenge** within the finance function today is that too much time is spent on **data preparation and cleaning due to manual data flows** hindering scalability and proper insight

Background

Our clients are typically in the **Private Equity** industry, and we are asked from our clients to help with the **following deliverables**:

- Align reporting with **strategic objectives**, e.g. value creation plans, credible data backed story at exit
- **Scalable reporting** e.g. - because of a M&A agenda, easy integrations new companies
- Enhancing **reporting quality and efficiency** in the finance function – (growing without additional cost FTE & Operational)
- **Utilize all available company data** to clearly understand profit margins, volume vs price and act on commercial opportunities

Challenges

Our clients typically **operates in different** countries and with different company structures.

- Leading to **different accounting regulations, currencies, pro forma**, and managing adjustments for **group reporting** e.g. eliminations **of intercompany transactions**.
- Managing **complexity using Excel and PowerPoint**
- **Different operational IT-structures**, e.g. CRM, ERP, consolidation system, data warehouse with varying data quality

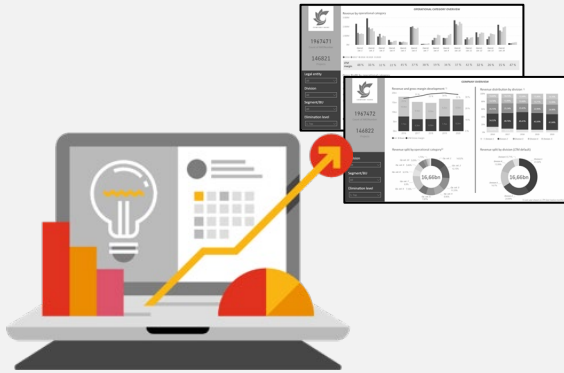

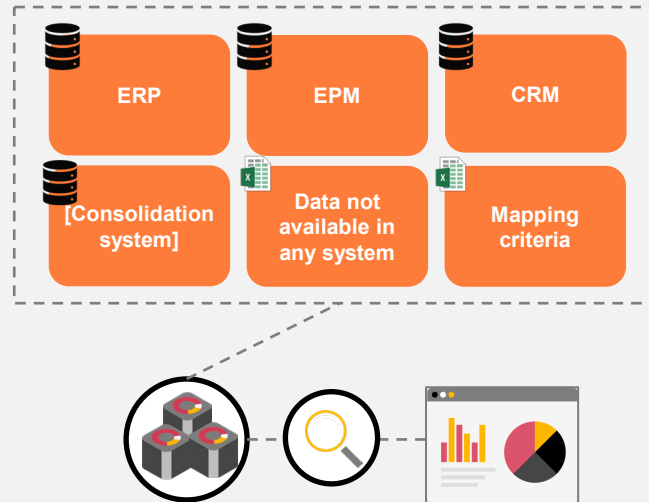


1 Design



- **Current state** analysis & case for change
- **Define the envisioned output** of the report / BI-tool
- Involve all **relevant stakeholders**

2 Data sources / structuring



- Identify and understand available **data sources**
- Understand **data relationships** and identify necessary mapping
- Build **tailored automated** dataflow from each relevant data source

3 Visualisation



- **Visualise** the output from the data model in the most relevant BI-tool for your specific organisation
- Creating **DAX structure** in Power BI

Helping a niched telecom service provider enhance operational reporting, boost efficiency, and break down data silos with data warehousing and Power BI

Industry: Telecom – connectivity service provider

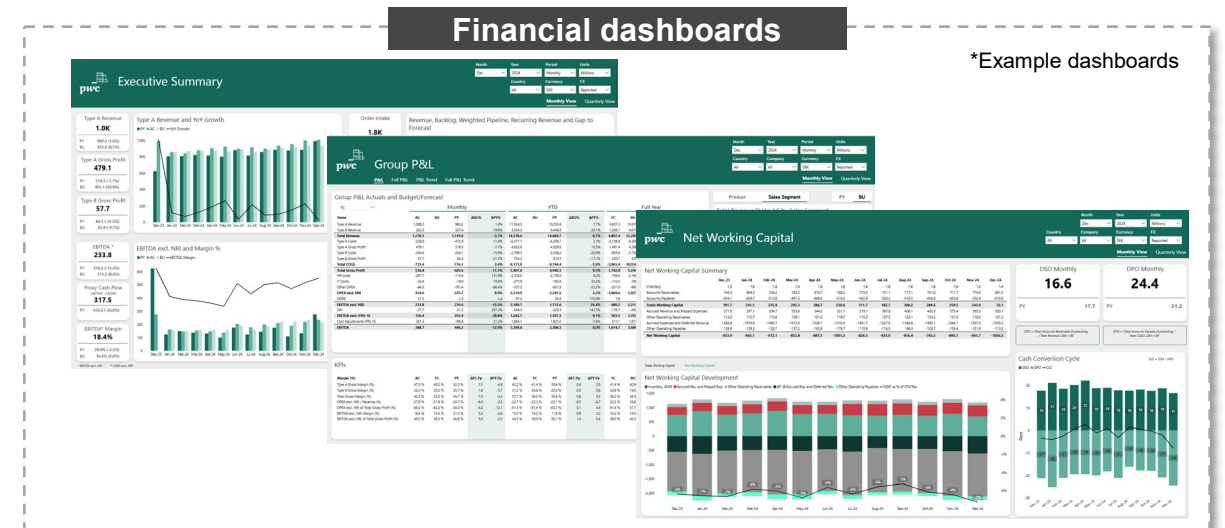
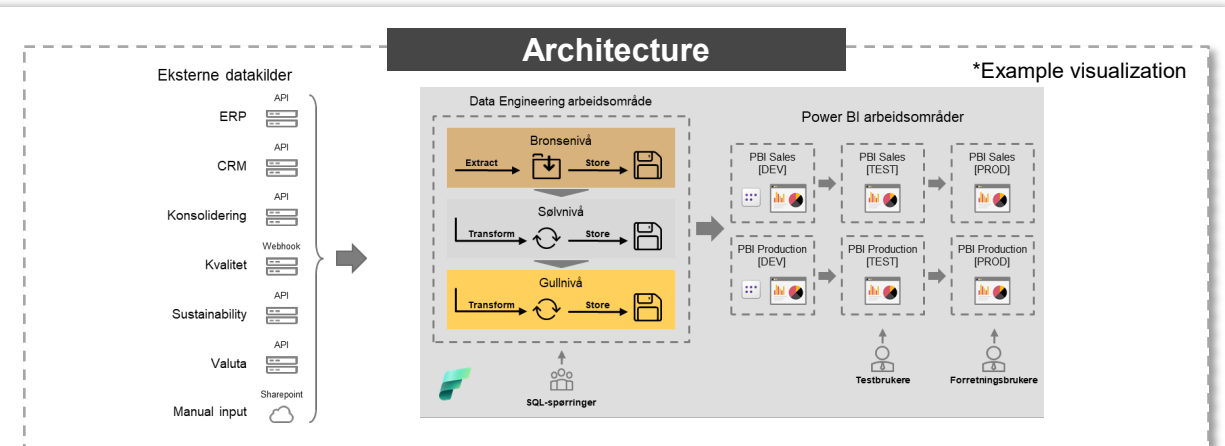
Delivery period: 2024 (~4 months)

Project description

An internet service provider, specialized in internet connectivity, was working with siloed data and static reporting from each individual source, hindering their ability to make data-driven decisions. They had a management **report of 100+ PPT**, taking extensive time putting together

Together with the client we accomplished

- Worked with IT and third-party provider for consolidation system to create a unified data-platform with integrations of current ERP
- Automated KPI reporting and improved data sharing processes
- Rolled out Power BI as the primary reporting tool
- Trained key resources for ongoing management

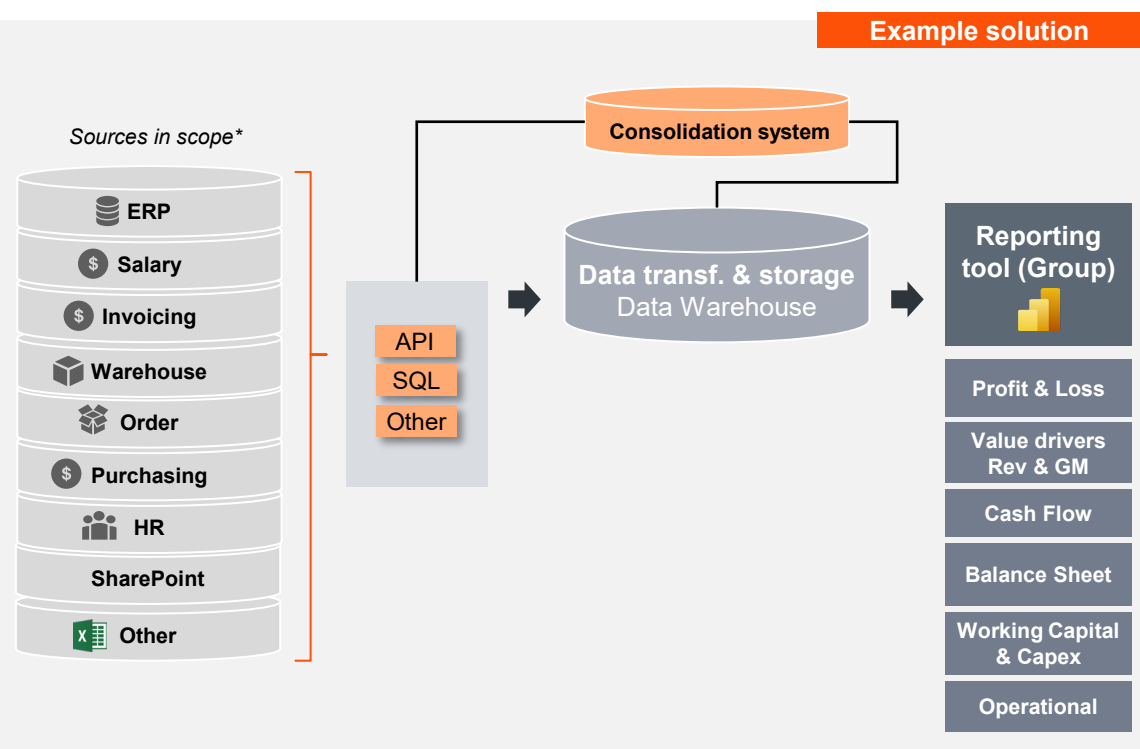


Solution overview –

To meet the reporting goals, we propose a data warehouse paired with Power BI; this client uses Snowflake, but if no data platform exists, we recommend Microsoft Fabric



Solution architecture and integrations



Integration: Data-feeds via API. Less frequent data can feed through Teams upload



End-to-end data management:
Automated to run daily or more frequent based on availability and APIs

Solution overview

Example

We propose a Microsoft Fabric platform to deliver the on the reporting requirements – starting with a diagnostic and design phase to map out requirements. Key focus is outlined below:

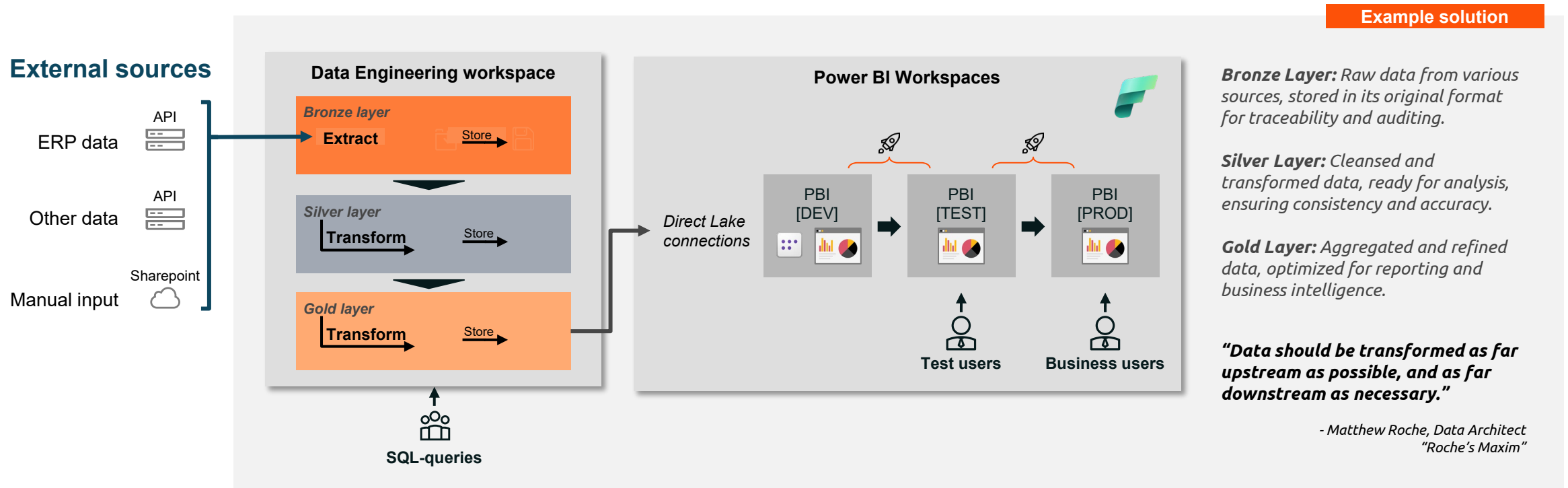
Example

Integrations: Initial analysis indicates at # integrations to bring in operational data from ERP system(s) alongside manual files from SharePoint / teams. Each of these sources need to be reviewed for data access and prioritize the implementation based on business need.

Power BI: We understand the solution will be used to meet operational reporting requirements across both legal entities and departments. As part of diagnostic and design phase we need to clearly define end user(s) – report purpose and design.

Microsoft Fabric: We believe Fabric to very relevant for the case. Its integrated nature means you do not need separate ETL tools to manage ingestion, transformation and visualization. The fabric capacity also powers the PowerBI processing needs.

Data architecture in line with best practice – Medallion Architecture ensures robust data management and scalable analytics



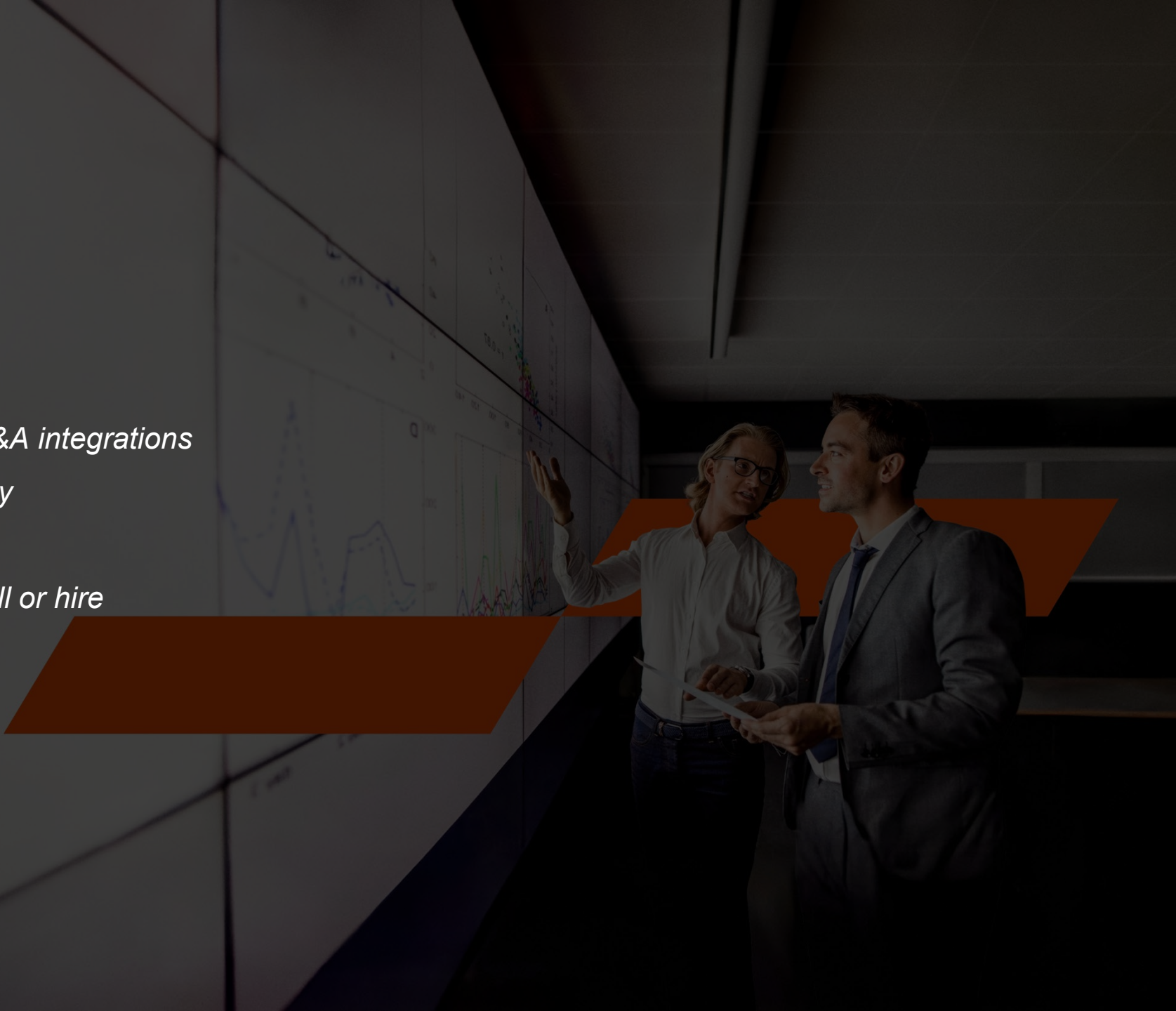
